The Oxford Region Planning Committee (ORPC) is an advisory group consisting of representatives from Oxford Borough and East Nottingham, Elk, Lower Oxford, Upper Oxford, and West Nottingham Townships. They meet at 7:00 pm on the fourth Wednesday of each month, when warranted. Meetings are held in the Lower Oxford Township Building at 220 Township Road, in Oxford, Pennsylvania, and are open to the public. The Committee met nine times in 2017: no meetings were held in February, August, or November (We met on December 7th in lieu of the regular November and December meetings).

Al Jezyck, Jr. of Elk Township served as Chair. Charles Fleischmann of Upper Oxford served as Vice-Chair. Ron Hershey of Oxford Borough served as treasurer. Stacey Fuller of Gawthrop Greenwood, PC was reauthorized as regional solicitor. Mark Gallant continued to serve as acting secretary.

Part 1: Accomplishments and Activities

The Oxford Region municipalities, with technical assistance provided by Brandywine Conservancy and the Environmental Finance Center at the University of Maryland, has started to develop a regional stormwater management program in an effort to help restore and protect local streams and the Chesapeake Bay. The Oxford Region municipalities have worked to identify opportunities for collaboration with stormwater management among Oxford Borough and the five Townships (Upper Oxford, Lower Oxford, East Nottingham, West Nottingham, and Elk). The municipalities agree that there are opportunities to work with each other on public education and outreach, administration activities, operation and maintenance, and implementation of best management practices (BMPs) in the long-term. These opportunities have the potential to provide cost-savings to the municipalities as well as benefits to water quality and other ecosystem functions. To date, this project has resulted in: completion of data collection and mapping of the municipal storm sewer systems for all municipalities and draft pollution reduction plans (PRPs) for two of the six municipalities. Work continues for collaboration with stormwater management among the Oxford Region.
