CALL TO ORDER

1. CALL MEETING TO ORDER

**RESOLUTION OF THE CHESTER COUNTY BOARD OF ELECTIONS
AUTHORIZING ADDITIONAL POLLING LOCATION CHANGE FOR THE
2021 PRIMARY ELECTION**

WHEREAS, the Chester County Board of Elections is required to select and designate polling places within the County, pursuant to the Pennsylvania Election Code (25 P.S. § 2726, *et seq.*) prior to the May 18, 2021 Primary Election; and

WHEREAS, there is an additional polling location change, other than those authorized by Resolution 09-21 on April 1, 2021 and Resolution 12-21 on April 22, 2021 for the upcoming Primary Election; and

WHEREAS, in furtherance thereof, the Chester County Board of Elections hereby designates the following additional polling place change for the May 18, 2021 Primary Election and thereafter unless changed by subsequent resolution:

From: East Fallowfield Elementary School, 2254 Strasburg Rd., East Fallowfield, PA

To: Hephzibah Baptist Church, 2237 Strasburg Rd., East Fallowfield, PA
