1. CALL MEETING TO ORDER

The Board of Elections (BOE) Meeting was called to order on Friday, October 4, 2019 at 12:15 p.m. in Courtroom #2 at the Justice Center, 201 West Market Street, West Chester, by Commissioner Kathi Cozzone. Honorable Judge Allison Bell Royer and Honorable Judge Jeffery R. Sommer were also present.

2. MINUTES OF PREVIOUS MEETING

▪ Motion

Commissioner Cozzone asked if there was a motion to approve the minutes from the Board of Elections meeting held on Monday, April 15, 2019. Judge Royer made the motion to approve the minutes from the Board of Elections meeting and Judge Sommer seconded the motion. Motion carried.

3. VALLEY NORTH PRECINCT SPLIT (Precinct 670)

RESOLUTION NO. 16-20**

**RESOLUTION OF THE CHESTER COUNTY BOARD OF ELECTIONS
AUTHORIZING THE CONSOLIDATION OF POLLING LOCATIONS FOR
PURPOSES OF THE 2020 PRIMARY ELECTION**

WHEREAS, the Chester County Board of Elections is authorized pursuant to the Pennsylvania Election Code (25 P.S. Section 2726) to select and fix the polling places located within Chester County; and

WHEREAS, Pennsylvania Governor, Tom Wolf, signed Act 12 of 2020 into law on March 27, 2020, to change the date of the primary election from April 28, 2020 to June 2, 2020, in response to the COVID-19 pandemic , and

WHEREAS, under Act 12 of 2020, this legislation additionally granted counties emergency relief and flexibility to consolidate polling locations for the 2020 Primary Election due to the constraints imposed in verifying polling locations and required staffing of election officials and poll workers; and

WHEREAS, in consolidating polling locations, the Chester County Board of Elections may authorize Voter Services to temporarily assign voters from a given election district to another polling location located outside of the voters' geographical precinct, for the purpose of casting an in-person ballot on June 2, 2020, and

WHEREAS, this effort is in anticipation of providing a physical location for voting as well as concerns about staffing issues at polls which are related to the COVID crisis, and

WHEREAS, in response thereto, the Chester County Board of Elections hereby selects and designates the following consolidated polling places necessitated by reason of the lack of the ability to use the previously designated polling place and/or by reason of the inability to provide fully staffed election officials which we believe to be equitably distributed across the County for purposes of conducting the 2020 Primary Election; and

WHEREAS, the Chester County Board of Elections hereby additionally authorizes Chester County Voter Services, no less than 15 days prior to the election, to post in a conspicuous place at the office of Voter Services, a finalized list of each place at which the election is to be held in each election district of the County. The finalized list shall be available for public inspection at the office of Voter Services and posted on the County's Website and be deemed approved by the Board of Elections; and

WHEREAS, should Voter Services, subsequent to the effective date of this Resolution but prior to the required posting date, determine that any polling locations that were designated to be consolidated are available at the prior polling place with appropriate election board staffing, it is hereby authorized that Voter Services can effect that change with appropriate notice, designation, and posting.

NOW, THEREFORE, BE IT RESOLVED BY THE CHESTER COUNTY BOARD OF ELECTIONS that Voter Services is hereby authorized to implement and effect the requisite procedures of consolidating polling locations within Chester County as set forth in Act 12 of 2020, the Pennsylvania Election Code, and consistent with the authority of this Resolution.

Referendum Question Plain English Statement Ratification

West Brandywine Township Referendum:

Do you favor the granting of liquor licenses for the sale of liquor in the Township of West Brandywine?

Proposed Plain English Statement:

Under Pennsylvania law, voters have the right to choose whether liquor licenses may be granted to businesses within their borders. Currently, West Brandywine Township is a “dry” township. This means that businesses within the Township are currently not allowed to obtain liquor licenses.

This ballot question, if approved by the voters, would authorize the Pennsylvania Liquor Control Board (PLCB) to grant liquor licenses for the sale of beer, malt or brewed beverages, wine, and spirits to qualified restaurants, taverns, bars, hotels, clubs, grocery stores, and other establishments within West Brandywine Township. Should this question be approved, the number of licensed establishments located within West Brandywine Township and a business’ eligibility to obtain a license will be subject to the quota provisions of the Pennsylvania Liquor Control Board and the approval of the Liquor Control Board, respectively.
