Memorandum of Understanding

This MEMORANDUM OF UNDERSTANDING dated October 25, 2018, is hereby made and entered into by and between the Chester County Economic Development Council, hereinafter referred to as CCEDC, and the County of Chester.

PURPOSE:

The purpose of this MOU is to document collaboration between CCEDC and Chester County in advancing three shared objectives:

1. To enhance and strengthen the county's innovation ecosystem and the startup company activity it supports;
2. To successfully conduct Year 3 of the "Take the Pulse" business trends and retention survey
3. To ensure continued effective Management and Administration of the VISTA 2025 strategic plan

WHEREAS, CCEDC's ideas x innovation network (i2n) program has a 10-year history of providing critical support and services that have directly benefited more than 100 emerging technology companies while making a significant positive impact on the local economy; and the efforts and benefits of i2n are directly aligned with the priorities of VISTA Goal Team 4; and

WHEREAS, one of the key strategies of VISTA 2025 is to conduct an annual business retention survey, "Take the Pulse," focused on the business trends and business climate of Chester County, and Spring 2019 will mark the fourth year the survey is conducted; and

WHEREAS, CCEDC and Chester County have led the development and implementation of VISTA 2025 since its inception in 2013; and CCEDC now supports the goal team process by attending and hosting meetings, building committees; defining standards, reporting metrics, and tracking progress towards goals, as well as sending invitations, tracking attendance, and other key administrative responsibilities;

The parties agree to fulfill the roles & commitments as outlined here. The parties hereby acknowledge the foregoing as the terms and conditions of their understanding.

CCEDC SHALL:

- a) Continue to provide Entrepreneurial Educational and Networking Events
- b) Continue to provide companies with access to Pennsylvania Keystone Innovation Zone (KIZ) tax credits
- c) Continue 1:1 advisory sessions with companies. Address company challenges by connecting small businesses with local resources
- d) Promote and market Venture ChesCo to the tech startup community

- e) Maintain & promote the ecosystem of resources for supporting entrepreneurs, with digital tools like the i2n website business ecosystem map
- f) Continue to build on the relationships and programming with educational partners: DCCC, WCU, PSU, Kutztown SBDC
- g) Provide a venue for entrepreneurs to pitch their company and receive feedback from experts and/or exposure to funders
- h) Foster connections between mature tech companies and startups for purposes of mentoring and investment
- i) Increase technology transfer by creating a conduit for entrepreneurs with research from institutions of higher education
- j) Continue and build on the strong history of economic development impacts generated by Chester County's emerging technology startup companies
- k) Maintain and increase i2n company internship opportunities for local university students with tech startups. Internships provide resources for i2n member companies to advance their projects and provide local students experience and inspiration to potentially stay in the county.
- l) Provide a report twice-annually (or more frequently as requested) detailing i2n activity and key performance metrics for the period
- m) Distribute and administer the 2019 "Take the Pulse" Business Survey, with a goal of over 400 responses. Response data will be analyzed and measured against responses from prior years to identify trends and key differences.
- n) Prepare a formal report using "Take the Pulse" data and distribute to key economic development partners as well as the public. Existing economic development programs and policies are then reviewed to ensure they are consistent with survey conclusions.

THE COUNTY SHALL:

- a) Allocate \$100,000 to CCEDC for the support and continuation of the i2n activities "a" through "k" described above
- b) Select an individual of their choosing to represent Chester County on the i2n Board of Directors,
- c) Allocate \$15,000 to CCEDC for the management and execution of the 2019 "Take the Pulse" business survey as described in items "m" and "n" above and the continued coordination and administration of VISTA 2025 generally.

The parties hereby acknowledge that:

This memorandum may be amended only by written agreement between the two parties.

Termination of this memorandum may be activated with a 30-day written notification to the either party.

This Intergovernmental Transfer Agreement ("Agreement"), by and between the Pennsylvania Department of Human Services, Office of Long-Term Living ("DHS, OLTL") and Chester County ("the County") provides for intergovernmental transfers of funds to DHS in order to provide the non-federal share of Medical Assistance ("MA") payments to county nursing facilities.

The County and DHS, OLTL (collectively referred to as "the parties") agree as follows:

1. **Program Description.** Pocopson Home (hereinafter "the County Nursing Facility") is a Pennsylvania licensed nursing facility located in and controlled by the County. The County Nursing Facility is an enrolled provider in the MA Program. The County will transfer funds to DHS. The transfer of funds from the County to DHS is known as an intergovernmental transfer ("IGT"). DHS will use the IGTs as the non-federal share (or "state share") of the MA safety net payment described in 5.b. below and the County Nursing Facility Access to Care Capitation Component of DHS' capitation payments ("Capitation Component") to the Community HealthChoices Managed Care Organizations ("CHC-MCOs") described in 5.d. below. The use of IGTs to fund Medicaid expenditures is authorized under the Social Security Act and the regulations of the Centers for Medicare and Medicaid Services ("CMS") (See 42 CFR 433.51 - Public Funds as the state share of financial participation).
2. **CMS Approval Required.** The MA payments described in Sections 5.b. & 5.d. of this Agreement are contingent upon CMS approval. To obtain CMS approval for the enhanced payments under subparagraph 5.b., below, DHS will submit a State Plan Amendment ("SPA") that includes those enhanced MA payments. Additionally, DHS must obtain CMS approval of the CHC-MCO agreements authorizing the Capitation Component. The County shall transfer the IGT funds on the date agreed to by the Pennsylvania Coalition of Affiliated Healthcare and Living Communities ("PACAH") and DHS ("IGT Due Date") only after DHS receives approval from CMS for the enhanced payments.
3. **Voluntariness.** The County attests that it entered voluntarily into this Agreement to make the IGTs described hereunder. The County further attests that it and its representatives have independently analyzed the validity of the IGTs and enhanced MA payments, and in making the final determination to enter into this Agreement, relied upon the advice of their advisors and legal counsel.
4. **Permissible Sources.** The County shall provide IGT funds to DHS that satisfy the requirements of 42 CFR 433.51 and that are not derived from an impermissible source, including, but not limited to, recycled Medicaid payments, Federal

money precluded from use as the state share, impermissible taxes, and non-bona fide provider-related donations. At the time the County makes an IGT to DHS, the County shall certify to DHS that the IGT funds are derived from state or local bonds, tax revenue or other permissible sources using the form attached as Exhibit A.

5. Transfer and Use of Funds. The parties will transfer and use the IGT funds as specified below.
 - a. The County shall make a one-time IGT in the total annual amount of \$4,849,589 on the IGT Due Date by transferring those IGT funds to DHS via the Automated Clearing House or via wire transfer to an account designated by DHS prior to the payments by DHS, OLTL for safety net payments to County Nursing Facilities as may be permitted under the Commonwealth's State Plan.
 - b. DHS, OLTL will use \$1,732,569 of the total annual IGT of \$4,849,589 to fund the non-federal share (or "state share") of a safety net payment to the County Nursing Facility for fiscal period July 1, 2018 through December 31, 2018, as authorized by the aforementioned, CMS-approved SPA. The total amount of the safety net payment will be \$3,628,416.
 - c. DHS, OLTL will use \$1,216,572 of the total annual IGT of \$4,849,589 for state-funded, county-administered human services programs for Fiscal Year 2018-19.
 - d. DHS, OLTL will use \$1,900,448 of the total annual IGT of \$4,849,589 as the state share of the Capitation Component of DHS' capitation payments to the CHC-MCOs in the Community HealthChoices ("CHC") Southeast Zone for January 1, 2019 through June 30, 2019. The CHC Southeast Zone is comprised of the counties of Bucks, Chester, Delaware, Montgomery and Philadelphia. The aggregate amount of IGT funds from Southeast Zone counties, which will be used as the state share of the Capitation Component is anticipated to be \$13,144,800. DHS, OLTL will include provisions in its agreements with the CHC-MCOs requiring the CHC-MCOs to use the Capitation Component of their capitation payments to increase payments to county nursing facilities for nursing facility services ("County Nursing Facility Access to Care Payments"). The total amount of County Nursing Facility Access to Care Payments in the Southeast Zone is anticipated to be \$27,528,377 for the period January 1, 2019 through June 30, 2019. The amount of the increase paid to each individual county nursing facility, including the County Nursing Facility, shall be determined through negotiations between each CHC-MCO and PACAH.
 - e. The County agrees that the dollar amounts set forth in subsections a. through d., above were calculated on the following assumptions, which, if altered, would change those amounts:

- i. The amounts were calculated using the Federal Medical Assistance Percentage ("FMAP") rates for October 1, 2017 and October 1, 2018. Consequently, the amounts may be adjusted to reflect any changes in the FMAP.
- ii. The amounts were calculated based on the anticipated amount of aggregate IGTs. Consequently, those amounts may be adjusted to reflect any changes in the final aggregate IGT amounts that participating Counties have agreed to transfer to DHS.
- iii. The amounts were calculated based on projected CHC enrollment numbers. Consequently, those amounts may be adjusted to reflect any changes in CHC enrollment.

If DHS determines the dollar amounts set forth in a. through d. above should be adjusted based on a change in one or more of the factors described in subparagraphs i, ii or iii, DHS shall provide notice to the County and PACAH. DHS and PACAH will negotiate any adjustments to be made as soon as possible within the contracting timeline.

- f. DHS shall use its best efforts to pay the safety net payments specified in subsection b., above, through its then-existing payment process within twenty-one (21) calendar days from the date that DHS receives the full IGT amount that is referenced in subparagraph 5.a. from the County.
6. The County Nursing Facility shall not be required to render the payments funded with IGTs made pursuant to this Agreement, in whole or in part, to the County; however, nothing in this Agreement is intended to, nor does it limit the County Nursing Facility's discretion to use the payments it receives as it deems appropriate.
7. Deferrals and Disallowances.
- a. DHS will use its best efforts to notify the County and PACAH within ten (10) business days if CMS defers or disallows Federal Financial Participation ("FFP") in the safety net payment or in the Capitation Component of the CHC-MCO's capitation payments or in the County Nursing Facility Access to Care payments made by CHC-MCOs to the County Nursing Facility which are funded through the Capitation Component. DHS will consult with and provide the County and PACAH a copy of DHS response to the CMS deferral or disallowance.
 - b. If CMS disallows FFP in the safety net payment or in the Capitation Component of the CHC-MCO's capitation payments or the County Nursing Facility Access to Care payments made by the CHC-MCOs to the County Nursing Facility, DHS shall recoup or require the CHC-MCOs to recoup the disallowed FFP, and any related interest and penalties, if any, by

offsetting the amount of the disallowance from payments otherwise due to the County Nursing Facility under the following terms:

- i. If the reason for the disallowance is ultimately found to be attributed to the County (for example, among other things, if CMS, or, if an appeal is taken, the court of final recourse, determines that the County did not provide proper documentation; that the County did not provide the IGT funds from a permissible source; or that the County was not a public entity for purposes of the IGT), then DHS shall recoup or require the CHC-MCOs to recoup the full amount of the disallowance associated both with the safety net payment and with the Access to Care Payment to the County Nursing Facility;
- ii. If the reason for the disallowance is ultimately found to be attributed to the design/structure of the IGT program (for example, among other things, if CMS, or if an appeal is taken, the court of final recourse, determines that this Agreement was impermissible or the public notice for the safety net payments was a defective notice), then DHS shall recoup or require the CHC-MCOs to recoup the full amount of the disallowance associated both with the safety net payment and with the Access to Care Payment to the County Nursing Facility less fifty percent (50%) of the amount used for state-funded county-administered human services programs under Section 5.c.

The amount recouped from the County Nursing Facility as a result of any disallowance shall not exceed the amount of the total safety net payment of \$3,628,416 plus any amounts the County Nursing Facility receives in County Nursing Facility Access to Care Payments less the amounts of \$1,732,569 plus \$1,900,448. In the event the amounts due under this subparagraph cannot be offset against payments otherwise due to the County Nursing Facility, the County Nursing Facility shall take such other measures as may be necessary to return the amount due under this subparagraph, at the discretion of DHS. The County Nursing Facility shall be permitted to retain the state share identified in Section 5.b. and 5.d. above.

- c. If DHS determines that meritorious grounds exist to appeal CMS' disallowance of FFP in the safety net payment or in the Capitation Component of the CHC-MCO capitation payments or in the County Nursing Facility Access to Care payments made by CHC-MCOs to the County Nursing Facility, DHS shall file an appeal with the United States Department of Health & Human Services Departmental Appeals Board contesting the CMS' disallowance. In the event DHS files such an appeal, DHS will not object if the County and/or County Nursing Facility seeks to intervene in and to appear with DHS as a party to the appeal.

8. If, after the County has made the IGT but before DHS pays the safety net payment authorized by an approved SPA, CMS, for any reason, does not permit or revokes approval of the IGT program described herein, then DHS is required to return the same amount of IGT funds to the County within twenty-one (21) calendar days of DHS receiving such notification.
9. Record Maintenance. The parties shall maintain necessary records and supporting documentation applicable to the IGTs and the payments to County Nursing Facilities and other Medicaid payments to assure that claims for total funds and federal funds are in accordance with applicable federal requirements.
10. Records Access and Cooperation. The County shall provide DHS or its designee access to the County's records and the supporting documentation relating to the IGTs and shall cooperate and assist DHS, as requested, in any federal or state review or audit of the IGTs or payments funded with those IGTs.

12. Term; Termination. This Agreement shall become effective on the earliest date it is fully executed by both parties. Notwithstanding the foregoing, either party may terminate this Agreement by providing written notice received by the other party prior to the date that DHS, OLTL submits the SPA for the enhanced payments to CMS. DHS will provide the County with notice of the anticipated date of its submission of the SPA no later than five (5) business days prior to the anticipated date.
13. Rights and Responsibilities. This Agreement is only intended to establish the IGT set forth above, and nothing in this Agreement shall be construed to limit, restrict or modify the respective rights and responsibilities of either party under federal or state law and policies, including the right of DHS to recover overpayments made to the County Nursing Facility other than the state share set forth in paragraph 5.b., above.

The parties, by their authorized representatives, have duly executed this agreement and each party acknowledges the receipt of a duly executed copy of this agreement with original signatures.
