If you cannot afford a private attorney, you may apply for representation by the Public Defender of Chester County (610-344-6940).

Failure to appear on your trial date shall constitute a violation of your bail. If you are on bail for this case, please call the Bail Agency (610-344-6886) upon receipt of this notice.
