Fees for Report of Intention to Adopt

NOTE # 3: If a Special Needs Waiver is filed and Chester County CYF is **NOT** the intermediary, the petitioner may file a Motion and Order requesting that the Investigation fee be waived. No fee is charged for filing the Motion and Order. The filings are accepted but the Report of Intent is NOT sent to Orphans' Court Administration unless or until the Motion to waive the fee is granted. If Motion is NOT granted, the Investigative Fees are due!
