**Subject:** 2018 Annual Review of Alleged PREA Incidents

During 2018 Year-to-date, Chester County Prison has investigated (24) PREA Allegations. There were ten (10) Inmate-on-Inmate allegations and fourteen (14) Staff-on-Inmate allegations. The findings and recommendations are as follows:

In 2017 there were one (1) reported allegations of Non-Consensual Sexual Acts. During 2018 there was three (3) reported allegations of Non-Consensual Sexual Acts.




The following is Corrective Action regarding the related incident:

The prison has ongoing training for staff in the area PREA. All investigations of sexual abuse are reviewed in accordance with 28 CFR § 115.86 to ensure that the facility continues to make appropriate changes where needed.
