It is your responsibility to be prepared for trial. If you have an attorney, contact him/her immediately. If you do not have an attorney, it would be to your benefit to contact one immediately. If you cannot afford a private attorney, you may apply for representation by the Public Defender of Chester County (610-344-6940).

Failure to appear on your trial date shall constitute a violation of your bail. If you are on bail for this case, please call the Bail Agency (610-344-6886) upon receipt of this notice.
