THE MINIMUM ELEMENTS OF THE RESTRICTIVE PROBATION PROGRAM ARE AS FOLLOWS:

\*\* All participants for RP must complete a Drug/Alcohol Assessment and Risk/Need assessment and submit the assessment with the application. All recommendations from the assessments must be followed as a condition of RP.

\*\* All RP technical violators will be required to attend Cognitive Behavioral Training (CBT).

\*\* 30 hours of community service may be waived if CBT is completed within the first 4 months of RP Supervision.

\*\*EHM and Jail Time must equal the Mandatory Sentence.

**Formula for sentence:**

**Jail = 1/6 of the mandatory sentence**

**EHC= balance of mandatory sentence with a minimum of 10 days**
