Watershed Plan Advisory Committee Communications

Communications via Mail:

- **July 22, 2019:** Sent all municipalities a letter announcing that the County was beginning an update to the County-wide Act 167 Stormwater Management Plan and *Watersheds*, the County's integrated water resources plan. The letter included a request for a primary and secondary contact for each municipality for the update process and a link to a webpage with information about the plan update process.

Communications via Email:

- **August 6, 2019:** A follow-up email was sent announcing the initiation of the update process for *Watersheds* and the County-wide Act 167 Plan. This email also announced the 2019 Chester County Municipal Stormwater Summit, which served as the first Watershed Advisory Plan Committee Meeting.
- **August 21, 2019:** An email was sent with information on date, time, location, and agenda for the Chester County Municipal Stormwater Summit. This summit was focused on the impact of changing precipitation patterns on Chester County's water resources and included a presentation outline the County-wide Act 167 Plan update process.
- **September 11, 2019:** A final reminder was sent for the 2019 Municipal Stormwater Summit.
- **October 11, 2019:** An email was sent with links to the presentations from the Municipal Stormwater Summit. This email also contained links to more information about the update process and announced the start of a series of public meetings to gather public input on the County-wide Act 167 Plan and model ordinance update.
- **October 22, 2019:** An email was sent with the full list of public input meetings scheduled for the fall of 2019.
- **December 23, 2019:** An email was sent announcing an agricultural stakeholder input event on January 23 at the Herr's Factory on Nottingham PA.
- **March 3, 2021:** An announcement was sent noting that the County has partnered with CEDARVILLE Engineering Group, LLC. to complete the update to the stormwater management ordinance. This email also announced that the next Municipal Stormwater Summit would be held virtually on April 16.
- **March 8, 2021:** An announcement was sent containing the date, time, and agenda for the April 16 Stormwater Summit/Watershed Plan Advisory Committee meeting.
- **April 5th, 2021:** A second reminder was sent with the information on the next Municipal Stormwater Summit and Watershed Plan Advisory Committee meeting.
- **April 27, 2021:** An email was sent with links to all presentations delivered at the Municipal Stormwater Summit and links to two surveys designed to collect input on the updated model ordinance and plan update process.
- **June 11, 2021:** An email was sent announcing a contract with CDM Smith to support technical analyses for the *Watersheds* and County-wide Act 167 Plan update. This email

also contained link two surveys: one focusing on water resources concerns and one focusing on water-based recreation concerns. The email also asked municipalities who had not yet sent the contact information for two representatives for the Act 167 update process to do so.

- **August 5, 2021:** An email was sent announcing the date of a public input meeting to collect feedback on the proposed changes to the stormwater management model ordinance. All municipal plan advisory committee representatives were invited to this meeting.
- **September 7, 2021:** A reminder email was sent for the updated stormwater management ordinance review meeting to be held on September 21.
- **September 24, 2021:** An email was sent to announce the date of the next watershed plan advisory committee meeting on November 5. This email noted that this would be the last presentation prior to the period of public review for the model ordinance.
- **October 25, 2021:** An email was sent with links to the updated drafts of the model ordinance, a summary of changes table, and all appendices. This email also included a reminder for the November 5 WPAC meeting.
- **November 3, 2021:** A final reminder for the November 5 WPAC meeting was sent with links to the draft ordinance documents.
- **November 23, 2021:** An email was sent announcing the start of the 45-day public review period. This email contained links where the final draft documents of the model ordinance could be downloaded. Email announcements were sent to all Chester County municipalities and school districts, surrounding municipalities and school districts, surrounding County Planning Commissions, the Chester County Planning Commission, and to Delaware Valley Regional Planning Commission as well as to other interested stakeholders and organizations.
