### CIVIL PROCESSING FEE SCHEDULE

Effective December 2021

All fees must be paid at the time service paperwork is submitted. The Sheriff's Office **accepts** payment by cash, certified check, money order, or law firm check and **does not accept** personal or business checks. **We do accept credit or debit cards over the counter in the office.**

All checks should be made payable to "Chester County Sheriff".

These fees are held in escrow until service is complete and/or the time for service has expired. The actual costs of service (mileage, county fees, surcharges, etc.) are then charged against the escrow account. If funds remain, a refund will be issued to the person or entity issuing the initial payment. If additional funds are due, the person or entity requesting service will be billed.
